

**Introduction to the System of Environmental Economic Accounting (SEEA)-  
Central Framework  
(e-Learning course)**

**4 March – 12 April 2024**

**Guideline**

**I. OVERVIEW OF THE COURSE**

This course introduces the SEEA Central Framework, the international statistical standards for measuring the interactions between the environment and the economy. It is comprised of 5 modules. The first module introduces the SEEA. Module 2 discusses accounting for physical flows while module 3 discusses accounting for environmental assets. The fourth module contains details on environmental activity accounts, combined presentations and indicators. The last module contains an overview of subsystems, applications and extensions.

**II. TARGET PARTICIPANTS**

Target participants are staff of national statistical offices and other relevant line ministries working on issues related to the environment. Those interested in learning more about the SEEA are also encouraged to take the course.

**III. LEARNING OUTCOMES**

By the end of the course, participants will be expected to:

- (a) understand what the SEEA is and how it can be used in measuring the interaction between the economy and environment
- (b) understand how to compile physical flow accounts, asset accounts and other accounts relevant to informing policies in the environmental space

**IV. COURSE DESIGN AND CONTENT**

Each module consists of slides with explanations. After all modules have been completed, participants will be required to complete a final test that will cover all modules. The course is expected to take a maximum of 15 hours to complete. Participants are also expected to attend weekly webinars. The webinars will provide an overview of the course topics and allow for participants to ask questions; more details will be provided at the beginning of the course. Furthermore, participants are encouraged to actively participate in the online forum of the course.
